The certification shall include two evaluations of the physical therapist licensure applicant's skills. One evaluation shall determine the skill level mid-way through the period of clinical service and the other evaluation shall determine the skill level at the end of the clinical service.

FSBPT: Federation of State Boards of Physical Therapy – This is the national governing body that administers the national physical therapy and state law exams. You register with and pay them to take the exam (s). FSBPT receives permission from PTBC to send you the Authorization to Test (ATT) Letter (more on this later).

Get Your California Physical Therapy License: A Step-by ...

To register for the CAL-Law exam, apply through the Federation of State Boards of Physical Therapy (FSBPT). Within 3-5 business days, they will send you an Authorization to Test (ATT) letter by email (similar to taking the NPTE).
